# Tax Credit Information

## WHAT IS TAX CREDIT?

Arizona allows state taxpayers to have a say concerning where some state tax dollars go. Taxpayers in Arizona are allowed to make a donation to individual schools in the Maricopa Unified School District and to deduct the amount of the donation from state taxes.

## HOW MUCH CAN I DONATE?

Arizona law allows state taxpayers to claim up to \$400 for married tax payers filing jointly. Single taxpayers, head of household, or married taxpayers filing separately can contribute \$200.

## CAN MY EMPLOYER MATCH MY DONATION?

Many employers will match their employees' tax credit donations. Check your company's website to see if this option is available.

## WHAT WILL THE MONEY BE USED FOR?

Every tax credit dollar will be used for extra curricular activities such as field trips, athletic programs, music programs, after-school clubs and student leadership training. Arizona now allows tax credits to pay fees of standardized testing for college credit or readiness which include the SAT, PSAT, ACT, AP, and similar tests.

## WHAT ELSE DO I NEED TO KNOW?

You do not need to have a child enrolled in one of our MUSD schools to be eligible for the tax credit. You do not have to be a Maricopa resident to donate money. You may donate less than the maximum amount allowed and still be eligible to receive the tax credit in the amount of your donation. You may also split your donation among more than one school.

## WHERE DO I DONATE?

You can complete this form and mail it to the Maricopa Unified School District Office. If you wish to use a credit or debit card, the donation can be made online on the Maricopa Unified School District homepage, or to go directly to the MUSD webstore type this address into your browser:
